#### **Apologies**

20.257 - Apologies were received from Cllr Nixon (SBC)

#### Declarations of Interest

20.258 A declaration of interest in relation to Item 13 on the Agenda, proposed Stopping Up of Highway, Meece Road, Cold Meece, was received from Cllr. David Beeston.

#### Public Question Time

No questions 20,259

#### Reports from Borough and County Councillors

#### 20.260 Cllr. Pert, Staffordshire County Council

- There is still concern locally about the Covid-19 pandemic and while the "R" number is coming down in Staffordshire there is concern that everyone continues to adhere to the advice on hands, face and space. There will be a further review of tiering on 16th December 2020.
- ii. Local GPs will be inviting more people to have a flu vaccination in the coming weeks.
- iii. The Borough Council has hosted three webinars designed to provide advice and guidance on talking the impact of the pandemic on communities. These are now available on the borough council website.
- The wheel wash is now operational at the BIFFA site in Cold Meece. iv.
- The County Council is now consulting on the proposals to create speed limit buffer zones on Yarnfield Lane and to reduce the speed limit on Meece Road and Swynnerton Road Cold Meece.
- vi. Discussion is taking place with local residents about finding a long-term solution to the problem of the hedge opposite the junction of Yarnfield Lane and Highlows Lane.

#### 20,261 Cllr. James, Stafford Borough Council

- Covid-19 vaccination is soon to be rolled out nationally and it is vital that everyone has a vaccination when they are invited to attend.
- ii. The Brown Bin scheme is changing in January and will in future be a paid for service.

#### Community Speed Watch report on the use of the radar speed sign

- 20.262 The report setting out figures for October and November and the cumulative results since June 2020 are set out in Appendix 1.
- 20.263 New reports are now available that set out the number vehicle per month by time and the total count of traffic by time.
- 20.264 There is now clear evidence that the device is having a positive effect on driver behaviour.
- 20.265 Resolution: It was resolved that arrangements are put in place to share the data with Staffordshire Police.

#### Crossing patrol - invitation to support a voluntary crossing patrol scheme

20.266 A proposal has been made to set up a voluntary scheme that would provide a crossing patrol outside Springfields First School. There are several questions that need to be resolved on the viability of the scheme which will need to be discussed with the school and the school governors.

#### Update on HS2 from the Stone Rail Head Crisis Group (SRCG)

- 20.267 This report covers the last two months from mid-October.
  - House of Lords Select Committee's 'Special Report' was issued on 19th October. Its contents were minimal and disappointing and did not accurately reflect the evidence session of 15<sup>th</sup> September or the follow up written evidence send to the Committee on 24<sup>th</sup> September.
  - A letter has been sent by the Parish Council to the Chairman of the Select Committee to reflect our concerns about their report.
  - The first session of the House of Lords report stage was held on 30th November and an important amendment to the Bill was passed regarding consultation with local people over road, rail and natural environment issues affected by Phase 2a. This amendment is likely to be overturned by the House of Commons and so the SRCG is working with our local MP to seek to secure its retention.
  - The second session of the House of Lords report stage will take place on 8<sup>th</sup> December 2020.
     No further amendments are expected to be passed.
  - The House of Lords Grand Committee discussed amendments to the Phase 2a Hybrid Bill on 9th and 12th November.
  - The Hybrid Bill is expected to be returned to the Commons for final consideration soon and this will result in Royal Assent in early January if not before.
  - The second meeting of the Annual HS2 Phase 2a Highways Sub-group was held on 26th November. This was attended by the clerk, Trevor Parkin and Jill Hood from Stone Town Council, as well as other reps from parish councils, Cllr Pert was also present. HS2 presented on a range of issues relating to highways and traffic and we expressed multiple points of concern and are seeking further involvement in the design stage that will follow Royal Assent.
  - One of the topics of discussion was HS2's proposed programme for delivery of Phase 2a following Royal Assent. The headlines are as follows:

- o Resumption of ground investigation works should have been October 2020
- Early environmental work (summer 2021), e.g. vegetation clearance, pond creation,
   species translocation
- o Early civil engineering works (ECW1), inc Hanchurch (autumn 2021)
- Early civil engineering works (ECW2), inc realigned Yarnfield Lane and M6 overbridge
   (18 months of design and lead into construction start in autumn 2022)
- o Main civil engineering works (MCW), start on site predicted to be summer 2023
- o Phase 2a completed early 2031
- It is likely however that there will be further delays to this programme.
- SRCG is planning to hold a Zoom virtual meeting to update local people on HS2 developments.
- Completion of the work to hold the meeting is being hampered by the Covid-19 Tier 3
  restrictions.
- The SRCG is aware that rumours are circulating about the start of works. Please be assured that the SRCG is on top of what is going on and will advise local people via this and other local forums. We would also request that if anyone is seeking further information about what is happening locally they should contact the SRCG.

#### Approval of the published minutes of the Parish Council meeting held on 13 October 2020

20.268 **Resolution:** It was resolved that the minutes of the Parish Council meeting held on 13 October 2020 were approved. As a result of the Covid-19 restrictions on public meetings the minutes will be signed at the first available opportunity.

To consider any matters arising from the minutes not covered elsewhere on the agenda.

20.269 No matters arising

#### Report of the Clerk to the Parish Council:

- 20.270 The Parish Council's current account balance on 7 December 2020 was £12,818.98 and the reserve account balance was £2,000 plus interest.
- 20.271 A cheque for £125 has been received from Yarnfield Forum towards the cost of the park benches purchased in the summer.
- 20.272 The schedules of payment for November and December 2020 are attached at Appendix 2 and 3.
- 20.273 The Borough Council recharge for the parish elections has now been agreed with 4 annual payments.
- 20.274 Resolution: It was resolved that the schedule of payments in Appendix 2 and Appendix 3 be noted.

#### Half year budget review

- 20.275 The Parish Council at the meeting in January 2020 approved a budget of £26,732.
- 20.276 2020/21 income

#### 20.277 Projects - 2020/21

- Road Project 30 mph buffer zone and 40mph limit in Cold Meece
  - o Project cost £4,000
  - County Council consultation now underway
  - Contribution towards the cost will be required in March 2021
- Neighbourhood Plan
  - Project cost £800
  - No commitments made
- Footpaths and pavement improvement (Footpath 10)
  - o Project cost £2,000
  - No commitments made
- Greenside Playground
  - The repair of the soft surface around the climbing frame and slide has been completed. A budget of £1,000 was set aside for this work. The final cost of the work was £1,551. The Council has a separate budget line of £500 for routine maintenance for the play equipment, which has been used to fund the overspend.
  - The annual inspection of the play equipment has identified a number of minor repairs that are considered in more detail below.

#### 2021 - 2022 precept

- 20.278 The precept for next year will need to be sent to the Borough Council by the end of January 2021.

  To meet this deadline the budget will need to be agreed at the Parish Council meeting on 12

  January 2021.
- 20.279 The preparation of the budget will be based on the work programme once it has been agreed.

#### Correspondence, circulars and issues

Playground inspection report

- 20.280 The annual inspection of the playground was undertaken in October 2020. No issues of any significance were raised in the inspection report
- 20.281 The report has identified a few minor defects that need to be monitored. Prices for repairs, which include the replacement of bolts that are showing signs of wear, missing bolt covers and replacement swing seats, are being sourced from the manufacturer, Wickstead Ltd.
- 20.282 A question was raised at the October 2020 meeting of the Council about the playground. A commitment was given at the meeting to paint the older swing, stand-up seesaw and roundabout.
- 20.283 Resolution: It was resolved that prices for the repairs and painting of the original equipment are obtained with a view to the work being done in the Spring 2021.

#### Community Winter Project

20.284 The Parish Council has launched a project to encourage people to make bunting that can be used in the next year to celebrate the community being able to meet again following the ending of Covid-19 restrictions. A simple pattern and instructions on how to get involved has been published on Facebook.

#### Bench renovation

- 20.285 A price of £130.00 has been received to repaint, using teak oil, the wooden bench in the Rose Garden at Cold Meece and the wooden bench on the village green. This work is scheduled to be undertaken in the Spring 2021.
- 20.286 Resolution: It was resolved that the price to paint the two benches is accepted.

#### Defibrillator

- 20.287 A request has been received to support a community defibrillator project. The funds to pay for the defibrillator unit have already been raised. The outstanding issue that needs to be addressed concerns finding a suitable location of the new unit.
- 20.288 Yarnfield Forum has two defibrillators in the village that it maintains. A third unit sited on Ashdale Park would enhance the coverage and make them more accessible for residents. The Parish Council supports the idea of increasing the number of defibrillators available in the village. However, it will be important to understand how the ongoing maintenance and supervision of the unit will be achieved.
- 20.289 **Resolution:** It was resolved that the Clerk approach AED donate to see how their proposal could be supported by the Parish Council.

#### Complaint about the formation of a gate onto the village green

- 20.290 The October meeting of the Council received a complaint about the installation of a gate onto the village green behind the bus stop on Yarnfield Lane. The Borough Council's Legal Services team have confirmed that they are not happy with the formation of the gate.
- 20.291 Resolution: It was resolved that details of the complaint are passed to the Borough Council with a view to them contacting the homeowner.

#### Police update on incidents recorded in the parish

20.292 The latest briefing paper on incidents in the parish reported to the police has been received and a copy will be circulated to members. (Appendix 4)

#### Youth Engagement

- 20.293 The parish council has been approached by a young resident of the village who is interested in the work of the Parish Council. The Parish Council is keen to engage with as wide a range of people and groups as possible. While some work has been done to engage young people in the parish this is still an area that is underrepresented.
- 20.294 Listening to young people and representing their interests not only strengthens local democracy, by involving the future electorate, but also delivers many outcomes that councillors seek to achieve.

Often youth engagement results in fresh and constructive decisions that really work for all those involved.

20.295 It is hoped this contact will lead to a group of young people coming together to discuss issues relevant to them and how they can influence the work of the Parish Council.

#### Trent Ground Maintenance - review of the contract

- 20.296 The budget for the 2020/21 contract to maintain the grass on the village green and in Cold Meece is set at £5,000. The contract was awarded to Trent Ground Maintenance at a price of £3,950 plus VAT.
- 20.297 After the final payment in November 2020 the final cost of the work carried out was £4,766.40 plus VAT. The increased cost was due to 4 extra cuts in Yarnfield and 2 in Cold Meece.
- 20.298 The first cut of the season was undertaken on 21 March 2020. The contract provides for the cutting season to start in the middle of April by agreement with the Clerk. The early start to the contract resulted in 3 additional cuts of the village green. However, it was this approach that resulted in the dramatic improvement in the grass on the village green,
- 20.299 The rate of growth of the grass on the village green was exceptional during the summer months. As a result, an extra cut was carried out on 16 July in an effort to maintain the high standard seen during the first part of the season.
- 20.300 Two extra cuts were undertaken at Cold Meece, one at the start of the season and one before Remembrance Day.
- 20.301 It is not possible to maintain the high standard expected on the current cutting pattern of fortnightly cuts and that an earlier start date for the first cut should also be considered for the village green. A cutting pattern that ran from 21 March to 7th October, using a three cuts per month system, would result in 21 cuts.
- 20.302 Resolution: It was resolved that Trent Ground Maintenance are asked to provide a details cost breakdown for items (i) (vi) set out below and that these are used to prepare the draft 2021-22 budget that will be presented to the Parish Council at their next meeting.
  - i. Consideration should be given to increasing the number of cuts to provide for a start date in mid-March.
  - ii. Consideration should be given to the proposal by Trent Grounds Maintenance to a follow 3 cuts per month regime on Yarnfield village green
  - iii. Consideration be given to weed control along the footpaths on the village green.
  - iv. Review the extent of the cutting area at Cold Meece on either side of the notice board.
  - v. The banks of the ditch on the north green requires two cuts each year to help keep it clear.
  - vi. Maintenance of the grass verge opposite Springfield First School

#### Covid-19 Update

20.303 The Borough Council has hosted 3 very useful webinars on 2nd and 3rd November dedicated to issues of Covid-19 and the local response that is available. The webinars were attended by Cllr Parkin, Cllr Cromey and the Clerk.

- 20.304 We have reached a stage in the Covid-19 pandemic in which many may think the problems will soon be behind us. However, this is unlikely to be realistic, and while the number of cases may be falling, and the promise of a vaccination programme is soon to be realised there are still real social and economic issues associated with the pandemic that need to be tackled.
- 20.305 There have been no new requests in the parish for support from residents since June.
- 20.306 Dialog with volunteers has been maintained, and while some are no longer available, there is still a core of volunteers willing to help.
- 20.307 The Borough Council has developed a valuable web-based resource called "Talk to Us" that contains a wealth of useful advice and links to dedicated websites on topics such as; debt, household bills, utility companies, homelessness, unemployment, redundancy, energy efficiency and fuel poverty.

- 20.308 One of the principal issues for the council has been not knowing who needs help, advice and support. The role for the Parish Council in the coming months will be to promote the "Talk to Us" website to make sure the advice, information and referral systems it offers are widely known in the parish.
- 20.309 Resolution: It was resolved that:
  - i. The Borough Council's "Talk to Us" website is promoted on the Parish Council Facebook Page and though the website.
  - ii. The Parish Council maintains contact with the volunteer group to update them on work being done locally.

#### Proposed Stopping Up of Highway, Meece Road, Cold Meece

- 20.310 The Parish Council has been invited to comment on a draft order proposed under the provisions of the Town and Country Planning Act 1990 Section 247 for the stopping up of the highway at Green Gorse Cottage, Meece Road, Cold Meece, Stone, Staffordshire. There is also an associated planning application for the change of use (Planning Application Reference 20/33182/COU) highway grass verge to be change to garden leaving 2.5m from the kerb edge open for visibility.
- 20.311 A response to the section 247 application is required only if the Parish Council has any issues with the proposal. Any comments would need to be lodged by 22 December 2020.
- 20.312 Resolution: It was resolved that the Parish Council has no objections in relation to both the stopping up order at Green Gorse Cottage, Cold Meece and the associated planning application

  Government Planning White Paper consultation response
- 20.313 A response to the White Paper was made using the Government's consultation website before the deadline on 29th October 2020.
- 20.314 The Government are now analysing the feedback. No date has been set by the Government for a response to the consultation.

#### Neighbourhood Planning - to agree the next steps

- 20.315 The Parish Council has previously considered this issue and agreed:
  - i. To break away from involvement with the Swynnerton Parish Council neighbourhood plan.
  - ii. To prepare a neighbourhood plan for the parish.

- 20.316 The Borough Council is currently carrying out a review of their Local Plan. This will have an impact on the need for a plan for Yarnfield and Cold Meece.
- 20.317 A neighbourhood plan would place the Parish Council in a stronger position to influence planning decisions. Without a neighbourhood plan the only recourse would be to respond to planning applications as they arise based entirely on the Borough Council's policies and standards.
- 20.318 Swynnerton Parish Council has commissioned Urban Vision to develop the evidence base for their plan. Much of this work will be the same as work that Yarnfield and Cold Meece will need to do. Urban Vision has suggested there may be an opportunity for some level of collaboration between the two councils. This would reduce the cost to each council if both were to agree to the proposal.

#### 20.319 Resolution: It was resolved that:

- i. An invitation is extended to Urban Vision to brief the Councillors on the work involved in preparing a neighbourhood plan and the role that they could play.
- ii. Urban Vision be invited to work with the Parish Council to prepare an application to secure up to £9,000 funding to support the development of the neighbourhood plan.

#### Reports from Parish Councillors on meetings/courses attended

- 20.320 The ability to hold any event that involved large groups was limited in line with the Government's Covid-19 restriction. However, Cllr Eyre and Cllr Ruston held a short Remembrance Day service at the Memorial in Cold Meece.
- 20.321 Cllr Parkin and Cllr Cromey attended the webinars run by the Borough Council.
