Apologies for Absence

23-456 Apologies were received from Cllr Roy James (SBC)

23-457 Nil

Public Question Time

Question 1

23-458 Can you advise when the outstanding Yarnfield Lane/Highlows Lane work is to be completed. These items have now been outstanding for several years.

- Network Plus work
- Severn Trent work to be started.
- Double yellow lines finalized

Response

23-459 The Network Plus remedial work on Yarnfield lane has been completed to the satisfaction of Staffordshire County Council.

23-460 Severn Trent are still exploring how best to resolve this problem including putting possible scheme designs to their hydrologist to establish what is feasible and what represents best value for money.

23-461 The double yellow lines at the junction of Highlows Lane is waiting for the Severn Trent Water Co work to be completed.

Question 2

23-462 I have been walking around the main part of the village and have noticed the appalling condition of the footpaths. Down to subbase layer in most places, a trip hazard etc.

The new farmer who owns the fields down Yarnfield Lane. I know he has to get his crops in and all the rain we have had but the state the road was in (clay mud) was appalling. It's a busy road, by 9.30am still no signage was put in place and the road had to closed for couple of days. What can be done. With HS2 being cancelled and the new farmer, who is responsible for cutting all the hedging down Yarnfield Lane. They haven't been cut for 3 years and in some places becoming a hazard for drivers.

Response

- 23-463 The state of the pavements in the parish is of concern to both residents and the parish council. A full response to this question is set out in Appendix 1.
- 23-464 The mud on Yarnfield Lane was reported to Staffordshire County Council who because of the extent of the problem closed the road because of the risk to road users.
- 23-465 HS2 Ltd has a continuing obligation to maintain their environmental work on Yarnfield Lane, including the cutting of the hedge. Balfour Beatty will be using tractor and hedgerow flail as well as manual working near any sensitive ecological receptors. This will form part of regular hedgerow maintenance within the wider area.

Question 3

- 23-466 Other than the press announcements on October 17th, has there been any other confirmed information provided to the Parish Council relating to Swynnerton Training Camp's utilisation for temporary accommodation whilst processing refugees?

Response

- 23-467 The question of communication from the camp is an issue for the MOD to answer.
- 23-468 The parish council has been able to establish that MOD Swynnerton is supporting the Afghan Resettlement and Assistance Policy, and that:
- i. The Afghan refugees passing through the camp will hold 'entitled persons' status.
  - ii. Afghan citizens who are eligible for relocation to the UK are able to relocate with a partner, dependent children and additional family members who are also deemed eligible for relocation under the ARAP by the Ministry of Defence and suitable for relocation by the Home Office.
  - iii. There will be 80 bedspaces at MOD Swynnerton.
  - iv. The camp will be providing temporary accommodation.
  - v. The intention is to only transfer people to MOD Swynnerton when they know that they have onward accommodation to move to, so their stay is limited to one week.
  - vi. The MOD are looking to resettle people into the MOD estate properties around the country.
  - vii. The MOD have said there will be no calls on any other public services.
  - viii. The MOD will provide a holistic package of care for the families, so the camp will not place any additional strain on local resources, for example health facilities or schools.

- ix. Once all the families have moved out of Swynnerton, the facility will return to regular MOD Service Personnel use.

Reports from Borough and County Councillors

23-469

Cllr Pert (SCC):

- Following the Government's announcement to cancel HS2 Phase 2a it is clear HS2 Ltd does not have an exit plan or time scale. Cllr Pert has written to both the leader and Chief Executive of Staffordshire County Council asking that they ask HS2 Ltd to provide details about how they will deliver the government's decision to cancel Phase 2a.
- It is important that the HS2 line in Staffordshire is put forward for disposal to ensure the plan cannot be resurrected in the future.
- MOD Swynnerton – the standard of accommodation at Swynnerton means Afghani refugees coming to the camp will already have a permanent place to go to and will only remain on site for up to 7 days.
- We have seen over the last 10 years a change in the level of flooding. Looking to the future, with the impact of climate change, it will be necessary to rethink what is considered to be acceptable and how we deal with issues such as building on flood plains or the better management of water courses to hold back flood water to allow for a more managed release.

23-472

Minute 21-254 – Village Green Project

- Meeting on 15 November with the lead officer at Stafford Borough Council. Instructions have been given to the Borough Council's solicitors to prepare the lease, which will include the amalgamation of the existing lease and payment of a pepper corn rent.

23-473

Minute 23-296 – Homes Plus Estate Management

- A site meeting has been held with a representative from Homes Plus which focused on the poor state of the pavements on Greenside and The Furlong and the garage site on Greenside.
- The outcome of the meeting and the work to be done by Homes Plus has still to be confirmed.
- It is proposed that more frequent meetings are held with Homes Plus.

23-474

Minute 23-299 – Road Safety

- The families affected by this issue have been visited by the PCSO and no further action is required by the parish council.

- 23-475 Minute 22-47 – Firing Range
- Planning permission for the new range at Stafford has been granted.
  - Stafford environmental health is still working to ensure proper management and operation the range.
- 23-476 A copy of the Update of Actions Report set out in Appendix 2 and posted on the parish council website was noted.
- Meece Road and Yarnfield Lane – flooding
- 23-477 Meece Road near to the junction with Yarnfield Lane has recently been closed for several days due to the heavy rainfall. The problem is in part due to the culvert under the drive of Gorse Cottage on Meece Road being blocked resulting in surface water running onto the highway. A meeting with Staffordshire County Council and the owner of Gorse Cottage has resulted in work being done to clear the culvert. Staffordshire County Council have also carried out work on the road gullies where the road floods.
- 23-478 A fault in the main sewer running from Swynnerton to Eccleshall has been identified and work is to be completed to repair the sewer.
- Community Action Group – report of the meeting held on 17 October, 2023
- 23-479 A defibrillator has been offered to the parish council from a local charity. The unit was originally purchased by the MS Society. A proposal was made and accepted that a donation is given to the MS Society.
- 23-480 A grant application is being pursued to pay for the installation of new defibrillators in the parish.
- 23-481 A suitable location to site a defibrillator in Cold Meece have yet to be found..
- 23-482 The Community Action Group is investigating the purchase of “bleed kits” to be placed inside the defibrillator cabinets.
- 23-483 **Resolution:** It was resolved that a donation of £200 is paid to the MS Society from the Community Action Group reserve budget.
- Yarnfield Park Residents’ Group – update report
- 23-484 Barratts West Midlands has written to residents recommending that the Resident’s Group form an Estate Management Company to take over the maintenance of the estate. This has raised concerns for the residents’ group who have asked for further information about the proposals.
- 23-485 It would appear that the proposal only affects Barratt homeowners and that the owners of Bovis Home will not be included in the proposals.
- 23-486 The Residents association will continue to press for further clarification on what is proposed and will report back to a future meeting of the parish council.
- Parish Clerk’s report:
- 23-487 Current Account bank reconciliation on 15 November, 2023 = £11,524.42
- 23-488 Schedule of payments since the last meeting = £2,757.81.
- Resolution:** It was resolved that:
- i. The schedule of payment set out in Appendix 3 for the period 10 October – 15 November is approved.

- ii. A transfer of £10,000 from the current account to the general reserve account is approved.
- iii. A transfer of £196.66 from the Community Action Group account to the general account is approved.

Update on Actions taken

- 23-489 The PCSO has provided an update report that is set out in Appendix 4.
- 23-490 A proposal has been made to buy a pull up banner to be displayed at events organised by the parish council.
- 23-491 **Resolution:** It was resolved to buy a pull up banner at a cost of £80 +VAT.
- 23-492 Work on the 2024 precept will need to be completed at the parish council meeting on 22 January, 2024.

Labour in Vain – Working Group update

- 23-493 An application to the Plunkett Foundation for support has been approved and a meeting arranged for 29 November, 2023.
- 23-494 The Working Group has agreed that it sets up a Community Benefit Society to submitting the Community Ownership Fund application and subsequently owning the Labour in Vain. The application to form the limited company will be supported by the Plunkett Foundation.
- 23-495 The Working Group has identified how it will use the £1,000 from the parish council: the Labour in Vain valuation, membership of the Plunkett Foundation, and the set-up costs for the Community Benefit Society.
- 23-496 The parish council has appointed Hinson Parry Estate Agents to provide an independent valuation of the Labour in Vain and the car park.

Neighbourhood Plan – update and next actions

- 23-497 Draft design code has been received from the consultant AECOM.
- 23-498 The project timetable for the final stages of the plan's preparation is being refreshed following a meeting with the council's consultant.
- 23-499 The initial consultation on open spaces did not generate the quality of response that had been hoped for. Further work on this will be undertaken in the new year.
- 23-500 An application to Locality is being prepared to fund the final stages of the neighbourhood plan development.
- 23-501 A newsletter covering both an update on the plan, consultation on open spaces and some parish news will need to be prepared.

Updates from Parish Councillors

- 23-502 Stone Parish Liaison Meeting on 1<sup>st</sup> November, 2023:
  - a presentation by officers from the Staffordshire County Council Highways department. Following the meeting a detailed written response setting out the highways department approach to the maintenance of roads and pavements was provided which is attached at Appendix 1.
  - New broadband infrastructure is to be installed in parts of Staffordshire and as a consequence of this Staffordshire County

Council are not planning to undertake any pavement replacements for the next two years.

- The question about insurance cover for first aiders raised by the parish council has confirmed that other councils are also affected by the lack of insurance cover for volunteers who provide first aid cover. It was suggested that the matter is referred to the National Association of Local Councils.

23-503 **Resolution:** It was resolved to contact the National Association of Local Councils about the issue of insurance cover for volunteer first aiders.

## Stone and Parish Liaison Group

### 1 November 2023

### Staffordshire County Council – Highways

All roads in Staffordshire receive routine highway safety inspections and these are completed monthly, quarterly, or annually depending on the road classification. We also receive thousands of reports from the public each month regarding highway matters.

Highway defects are risk assessed based on the severity of the problem, volume of traffic using the route and position of the defect for example. The inspection considers these factors to determine the safety risk the problem presents. Any raised remedial works following the inspection are given an appropriate category of priority which dictates the timescale for repair.

The whole county is covered by a small team of inspectors, routine inspectors carry out pre-scheduled inspections of the highway network, while reactive inspectors supplement this by responding to calls for service made by the public and establishment organisations.

Any defect reported is assessed/identified and suitable action is instigated. Where works are thought necessary a job number is allocated for scheduling and completion. It should be noted that though a member of the public may think that a defect deserves attention and rectification, it is entirely possible that a defect may not meet the threshold for repair according to the response framework.

In addition to the already mentioned inspectors, further inspectors work to ensure that works undertaken by 3<sup>rd</sup> parties, such as service providers and utility companies, are carried out responsibly and in accordance with guidelines regarding reparation standards.

The provision of reliable, safe, efficient utility services including gas, water, electricity, water, and telecommunications requires both maintenance and improvement works to assets used to supply these essential services that we all rely on. Most of the utility apparatus is located within the public highway. Utility companies understandably wish to assure that they can continually provide their essential supplies and to enable them to do so means they have a legal right to work in the highway. Utility providers do not require the permission of the highway authority to undertake works as this is given by licence from the Secretary of State, to enable them to comply with their own governing service supply legislation. Additionally, they answer to OFWAT and the DWI who are their industry regulators. As such they are ultimately

responsible for the delivery of their own works and ensuring effective traffic control.

For this reason, we actively encourage public feedback to be directed to the third party responsible for utility works.

Works in the highway undertaken by SCC are currently carried out by SCC working partners Amey.

Staffordshire County Council have a strategic partnership with Amey for the delivery of a wide range of highway services from day-to-day maintenance including emergency, and routine repairs, grass cutting, gully emptying and winter service through to design and delivery of major projects such as the proposed works at Redhill and Beaconside, along with the recent resurfacing of the A34 Walton Island in Stone.

As a result, the annual contract value varies depending on several factors including the value of capital grants and awards from central government and, investment from the County Council. In the current financial year, the value of the contract is expected to be circa. £89.3m (£16.0m Revenue and £73.3m Capital).

The main payment mechanisms in the contract between the County Council and Amey are priced with activity schedule, target with activity schedule and cost reimbursable.

Costings for individual works are not available.

Further works in the highway may be undertaken by developers, such as housing companies, developing infrastructure supporting building projects. It is the responsibility of developers and their agents, to plan and administer works in liaison with SCC. SCC does not have control or access to these plans, nor does it have detail regarding costings.

To summarise, generally any works in the highway are carried out by three classifications of body:

1. Amey, on behalf of SCC
2. Utility/3rd party companies, employing their own staff or contactors.
3. Developers employing their own staff or contactors.

Staffordshire's road network spans over 3500 miles and has a replacement value of around £8 billion. Ideally the County Council would require around £38m maintenance investment each year, to keep roads and bridges in a reasonable condition. The funding available to the County Council has always fallen short of what is realistically needed however, and this historic under-investment over many years has now resulted in significant pressure on maintenance operations provided by the County Council.



These operations are not limited to pothole repairs and involve the upkeep of over 6000km of roads, 4,500kms of footways and cycle ways, 200kms of retaining walls, 50kms of safety fencing, 1,200 bridges and culverts, 180,000+ highway gullies, an unquantified length of highway drainage systems, around 2.5 million sq. meters of grass verges, a winter maintenance operation (gritting routes and restocking over 4000 grit bins and salt piles) and a 24-hr emergency response service.

Jobs identified as being necessary may fall within four general categories. Category 1, 2, 3 and 4.

1. Category 1, Urgent safety issues to be addressed ASAP as a matter of urgency.
2. Category 2, ideally within 7 days.
3. Category 3, Ideally within 28 days, however practically defects may remain for significantly longer periods.
4. Category 4, No timescale.

Works classified in the lower categories may be superseded by works in the higher categories which are prioritized.




Works in the lower categories may also be delayed, being coordinated with others in an area, to work in the most efficient cost effective manner, or to minimize disruption.


Giving various examples.

- patching of several potholes in an area may be carried out individually over a period of time, rather than resurfacing a whole area to minimize disruption.
- Works may be delayed pending more widescale anticipated repairs.
- Drainage works may be held pending routine cyclical scheduled works.
- Repairs may be not done as a scheme, development or routine maintenance projects may be pending.

1.3 Would the parish council consider placing road traffic signs on Yarnfield Lane warning about the risk of deer on the road?
